We kindly invite you to participate in the Electronic process and provide your quotations against below general terms and conditions.

General Terms and Conditions:

1. **Submission Period** : The electronic quotation must be submitted to following address within three (3) calendar days from the above date of publication of the short notice i.e. on or before 05 December 2019 16:00 Hrs local time.
2. **Validity of Quotation**: The quotation offer should be valid for at least 45 days after the last date of the quotation submission.
3. **Quotation Opening**: All received quotations shall be opened on 06 December 2019 on 14:00 Hrs local time at the venue mentioned below with/without presence of prospective bidder/his representative/nominee.

4. Information to the bidder

- a) **Mode of quotation**: The electronic quotation shall be sent through email only. Other electronic means of communication (telex, fax) shall not be considered. Quotations sent through air freighted / couriered shall NOT be considered.
- b) **Quotation Submission**: The electronic quotation must reach within stipulated date and time on following email address: ed@nac.com.np and epd@nac.com.np
The attached file/quotation should have following requirements:
 - a) Exclusively in PDF format. Note: if email attachment size is greater than 5 MB please send multiple emails with each attachment less than 5 MB



- b) All PDF attachments must be *password protected*. Note: the password for the quotation to be provided via separate email on 06 December 2019 after 1000 Hrs local time at ed@nac.com.np and epd@nac.com.np
- c) **Preparedness of the quotation:** The bidder must provide following documents along with the quotation:
- a) Copy of Company/ Firm's Registration Certificate
 - b) Company Description
 - c) Scanned copy of declaration as per the format in Appendix-A of this notice.
 - d) The company's EASA/FAA approval certificates
- d) **Payment terms:** Please mention payment terms on your commercial proposal.
- e) **Queries:** Any queries should be addressed to following email address within 2 days of the first date of publication.

- f) **Disclaimer:** NAC reserves the right to reject any or all of the quotations submitted at any stage before executing contract without assigning any reasons whatsoever and without any obligation and liability whatsoever. NAC also reserves the right to hold or withdraw or cancel the process at any stage under intimation to the prospective bidder who submits the quotation.
- g) **Evaluation of the quotation:** The quotation shall be evaluated on least cost basis. NAC can communicate / ask further clarifications on the received quotation to the bidder if required. The quotation accepted shall be notified via email after the evaluation of the quotation. If the negotiation with the winning bidder could not materialize, NAC will invite the bidder whose quotation has second lowest cost to negotiate a contract.
- h) **Signature and Stamp:** The submitted documents should be duly signed with office stamp.

- I. **Dimensions**
 - a) For A330: Size (length x height): 10 ft x 7 ft , Qty:04
 - b) For A320: Size (length x height): 6 ft x 5 ft , Qty:04
- II. **Lead time should not exceed 15 days after issuing purchase order.**
- III. **The bidder should have EASA/FAA approval certificate and the supplied items should be supplied with applicable certificates.**
- IV. **Interested Bidders can download the high resolution photo of decal from NAC's website.**
